

This year, the NYS Division Veterans Services announces a program to assist our Posts with Capital improvements. this is a mere overview of the program in January 2023 there will be a seminar covering the program and assistance on how to proceed. I will ask the Department to publicize this date when it becomes available. This will be a chance to do some capital improvements on your posts which without the posts may not be able to afford these improvements.

**NEW YORK STATE DIVISION OF VETERANS' SERVICES VETERANS' NONPROFIT CAPITAL PROGRAM REQUEST FOR GRANT APPLICATIONS (RGA)**

*To maintain a fair and open process all questions regarding this RGA must be submitted to [grants@veterans.ny.gov](mailto:grants@veterans.ny.gov). It is a violation of the New York State Procurement Lobbying Law to directly contact personnel at DVS or its affiliates regarding this RGA prior to the announcement of the grant awards.*

**This is the overview of the project.**

*In order to effectively address the continuing need for quality veteran services, New York State is providing \$5 million in Grant funds to nonprofit veterans' organizations to make capital improvements to facilities that serve veterans. The Veterans' Nonprofit Capital Program ("VNCP") was established within the 2022-2023 NYS Budget.*

VNCP will be administered by the New York State Division of Veterans' Services (DVS) and is expected to be highly competitive. Veterans' organizations are strongly encouraged to review the Frequently Asked Questions (FAQs) for additional information prior to applying. Additionally, there will be a webinar that will outline the Application process as well as the opportunity to submit questions (see Section 7) which will be posted for all prospective Applicants on Grants Reform Gateway to review

prior to the Application due date of March 31, 2023.

We are at the halfway point in the VFW year. With this in mind, it is time to begin to evaluate where your Post is and begin the task of looking for qualified candidates for the 2022-2023 VFW Year.

Members, of each Post at their annual election, are responsible to elect officers and as such, should elect officers who, will protect its members, its interests and the assets of the post. The by-laws of the Veterans of Foreign Wars spell out duties and responsibilities for each officer. However, most Posts elect the trustees as ***an afterthought***. "*There is nothing to this job!*" **Does this sound familiar???** In-fact, the task of post trustee, is the most important position in your Post. Trustees **not** responsible the Commander, and **not** to the Quartermaster, but to the **members of the Post**. Their signature on the trustees report indicate to the membership they have done their job with the intensity and exactness necessary to protect the Posts interests and assets as they would do for their own home. There is information online for the trustees to Complete their tasks. **DO NOT RELY ON THE QUARTERMASTER TO COMPLETE TRUSTEE REPORTS.** The first line of offense for trustees is the information online. Read, learn, ask questions and look to the district officers for direction. Look for information at: [www.vfw.org](http://www.vfw.org) or [www.vfwny.com](http://www.vfwny.com).

We will discuss the Voucher Program at the winter C of A. Anyone receiving a VOUCHER, must stay at the Host hotel, unless sold out and then the alternate site. If you stay someplace else, you are on your own. While we are at the meetings, general sessions, turn the vouchers into the chairperson or at the general session bring them to me. Have the Sgt-at-Arms bring them up front. Please do not hand them to me as I am getting into my car after the completion of the event.

The IRS uses electronic methods of tracking each person and or entity who should file tax returns and or 990 reports each year. If you do not complete, file and have accepted a 990 for 3 years, the IRS automatically suspends your not-for-profit status. you must reapply for that status. If you have any questions, please, contact a tax consultant for direction.

## Thomas Todaro PSC DIRECTOR OF VETERANS SERVICES



Comrades,

The Department of Veterans Affairs has received nearly 113,000 new disability compensation claims for benefits created by the landmark toxic exposure law signed in August, pushing the VA to aggressively search for new hires to handle the influx of veterans into the system.

VA Secretary Denis McDonough said Tuesday that claims applications this month were 19% higher than October 2021, with the VA receiving 1,000 more claims a day than it usually does, requiring the department to take steps to recruit additional health and benefits personnel and offer incentives to retain current employees.

"With the promise of so many more veterans coming to VA for care under these provisions, we need aggressively to hire the people who will deliver the benefits," McDonough said during a press conference in Washington, D.C.

The department began accepting claims for illnesses deemed as linked to military service by the Promise to Address Comprehensive Toxics, or PACT, Act in August after the legislation was signed by President Joe Biden.

The illnesses include 23 respiratory illnesses and cancer tied to exposure to burn pits and other air pollution from the Persian Gulf War and post-9/11 conflicts; radiation-related illnesses for veterans who participated in certain cleanup operations in the 1960s and 1970s; and hypertension and monoclonal gammopathy of undetermined significance, or MGUS, for Vietnam veterans exposed to Agent Orange.

Under VA policy, veterans with one of these illnesses must submit evidence they served in an area and are eligible for benefits, but they don't have to send medical evidence that their condition was service-related, effectively speeding up processing times.

While the VA is accepting PACT Act-related claims now, it will not begin processing them until January -- a provision in the law that gave the department time to hire additional personnel to review the claims.

According to McDonough, the VA is now processing roughly 7,500 claims a day and has reached as many as 7,900 in a single day, a figure he described as a "new normal."

Greetings from your National Council Member!

We have not had a National Council of Administration Meeting (C of A) since last reporting to you and things have been relatively quiet since then.

As we roll into December, Commander-in-Chief Borland wants to make sure we do not have a slowdown in our recruiting and retention efforts and has announced a new membership incentive for the month of December. Posts will receive a grant of \$10 per member deposited via ACH into their respective Post account for each NEW and REINSTATED member. Departments will also receive this \$10 grant for members-at-large who are submitted with recruiter credit attached.

If you are a veteran enrolled in VA health care, you can now receive the toxic exposure screening at VA medical centers and clinics across the country. If you are not enrolled in VA health care, you will be eligible for the screening once you complete the enrollment process. These screenings will become a regular part of your medical appointments and, if you believe that you experienced toxic exposure during your military service, you will be connected to support and resources.

Please be advised: An individual identifying himself by the name of Patrick Roth is sending targeted messages containing inciteful language to leadership at VFW Departments, Posts and potentially, Districts. Please do not engage in any correspondence with Roth. Simply delete his message(s) and block him from further communication.

On the legislative front, the VFW currently supports 175 bills; and opposes one bill pending before the 117<sup>th</sup> Congress.

Administrative Operations at National is engaged in 13 Article IX Disciplinary Actions, 22 administrative actions and seven membership eligibility challenges. There are 53 Posts under suspension and one Post charter revocations and



completed two pursuant to Sections 209 and 212 of the National Bylaws. The organization has 5,774 chartered Posts.

Our next National C of A will be in early March when I head out to Washington, DC for the Voice of Democracy and Patriot Pen Awards during the Legislative Conference scheduled for 3-8 March 2022.




Comrades,

## VA CLINIC OPENS IN ONEONTA

ONEONTA, NY (WKTV) - The Department of Veterans Affairs will open a VA Clinic in Oneonta this month. Upon notification of the impending expiration of the contract at the Bainbridge Community Based Outpatient Clinic (CBOC) location, VA initiated its normal federal solicitation and award process. In response to a request, an additional assessment of Veteran geographic and accessibility data was conducted to ensure maximized benefit for Veterans in the area. During this process, VA's primary consideration remained focused on its ability to effectively meet the needs of Veterans, improving access, and enhancing care while meeting federal regulations and requirements.

As a result, the Stratton VAMC is expected to open the newly relocated clinic in Oneonta at 1 Foxcare Drive, Suite # 104 on December 6. This is a move from its previous location at 109 North Main Street Bainbridge, NY.

The relocated clinic provides more and enhanced services as well as additional space for patient privacy, enabling VA the ability to implement Patient Aligned Care Teams (PACT) and expand services through telemedicine - doing so in an economically responsible way that maximizes taxpayer dollars.

The move also increases the accessibility of care to Veterans, providing it in a location where an overwhelming majority of Veterans reside.

Letters have been sent to every Veteran utilizing the clinic at the prior location in Bainbridge, informing them of the change of location and providing contact information for Jodeya Jackson, Stratton VAMC's Primary Care Administrative Officer at (518) 626-6561.


